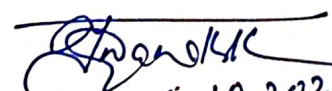

The institution is adopting the curriculum approved by the affiliating University and enables effective curriculum delivery to students through a well-planned academic calendar. The college follows semester pattern with Choice Based Credit System. NEP implemented. To sensitize students with the cross-cutting issues relevant to gender, environment, sustainability, human values and professional ethics the college supplement the curriculum by organizing some programmes. Online Feed-back on curriculum from the students, faculty members and Alumni were collected, analyzed and Action Taken Reports have been uploaded in website.

Qualitative analysis of Criterion 2

The Admission to UG Programmes are through centralized online system of Commissioner of Collegiate Education. The reservation policy has also been adhered to Advanced and slow learners are identified by adopting various teaching pedagogy. Students are continuously assessed throughout the semester and evaluated. The college is facilitated with ICT enabled teaching to some extent. Three teachers developed e-Content and videos and uploaded in youtube. Internal examinations are conducted regularly and evaluation is transparent and shared with the students. 13 faculty members have NET/SET and 9 faculty members awarded Ph.D., during the period. 4 Teachers have Received best teachers Award from the state government and district administration. The college practices experimental and participatory learning. The college has adopted outcome based educational mechanism to ensure the attainment of course outcome and programme outcome. POS, PSOS and COS are well displayed on the website. There is continuous evaluation of progress of students, are the results of which are intimated to students and their parents.

Four students of Zoology along with their mentor have published a research paper in Scopus indexed Journal. A few faculty members published books. Extension activities are undertaken by NSS, Women Development Cell, Red Ribbon Clubs and various awareness programmes including electrical literacy, are conducted within the campus and the nearby community. Tree Plantation, Medical Camps, Blood Donation Camps, Veterinary Camps are regularly organized in the adopted villages by NSS. The college received Gold Medal with the certificate from Indian Red Cross Society, Srikakulam.

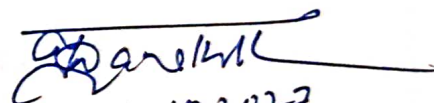
